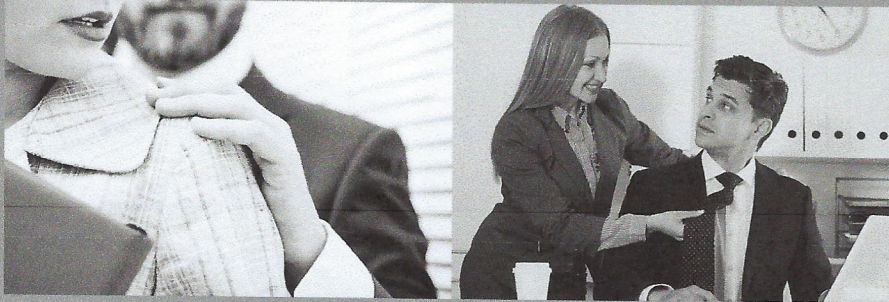

DO EMPLOYERS HAVE TO PAY EMPLOYEES DURING TRAINING?

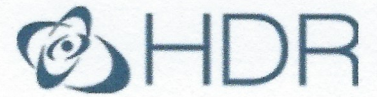
Yes. State Law makes it clear employees must not be required to take such training during personal time. The training must be provided by the employer as part of the individuals' employment.
